MERCHANT MARINE CIRCULAR MMC-346

- To: Masters, Ship-owners, Operators, Company Security Officers, Ship Security Officers, Panamanian Merchant Marine Consulates, Legal Representative of Panamanian Flagged Vessels, Recognized Organizations (RO's) and Recognized Security Organizations (RSO's) of Panamanian Flagged Vessels.
- **Subject:** Amendments to the Ship Security Plans (SSP) for Recognized Security Organization (RSO) duly cancelled.
- Reference: Law No. 38 June 4th, 1995 UNCLOS 1982. Resolution J.D. No. 026-2020 of February 27th, 2020. MMC-131 Authorized Recognized Security Organizations (RSO). Reports and Fees. MMC-359 Guidance for the implementation and certification of the ISPS Code.
- 1. The purpose of this Merchant Marine Circular is to inform all owners and operator companies that during the process of the last RO Code Audit, this Administration cancelled some Recognized Security Organizations (RSO's) responsible for the review and approval of the Ship Security Plan (SSP) for vessels of Panamanian Flag.
- 2. Due to the situation mentioned above, the Panama Maritime Authority authorized the Maritime Ships Security Department to receive, review and approve the amendments or modifications to the Ship Security Plans approved by Recognized Security Organizations, which have been sanctioned by the Panama Maritime Authority, with the total revocation of its authorization to render the services as Recognized Security Organization.
- **3.** This Administration will may approve the amendments relating to the following matters and it is only applicable for those Recognized Security Organizations that were cancelled on MMC-131.

- 1. The CSO's identity and contact details
- 2. SSAS procedures
- 3. Procedures for reporting incidents
- 4. Procedures for maintaining confidentiality of documents
- 5. Procedures for controlling access to the ship
- 6. Procedures for acknowledgement changes in security levels
- 7. Measures on procedures at security level 2 and 3
- 8. Frequency of security equipment testing
- 9. Frequency on conducting drills and exercises
- 10. Change of vessel name
- 11. Change of owner or any contact details that affect the SSP
- **12.** All changes to an approved SSP related to the requirements of ISPS Code A/9.4.1 to A/9.4.18 shall be reviewed and approved.
- **13.** Any other not specified in the previous list.
- 4. The review and approval of the amendment of the Ship Security Plan, should not be considered of declaration of full compliance and/or the ensure certification in accordance with the applicable requirements. Verification of implementation of the requirements at the intervals established in accordance with ISPS Code Part A, and Chapter XI-2 of SOLAS 1974 as amended and provisions of SSP shall be performed onboard the subject vessel.
- 5. Starting from February 15th, 2021 the online application for Ships Security Plan Amendments will be available on the following website link <u>http://certificates.amp.gob.pa/certificates</u>, this Administration recommends using Google Chrome, Opera, Mozilla Firefox, Safari and Microsoft Edge.
- 6. The following documents should be submitted, through the following website link: <u>http://certificates.amp.gob.pa/certificates</u>
 - **1.** Document of Compliance (DOC)
 - 2. Safety Management Certificate (SMC)
 - 3. Ship Security Plan and Approval Letter
 - 4. The modified pages on the SSP and the Amendments index sheet
 - 5. Evidence of the amendment(s) requested (if apply)
 - 6. Official payment receipt of USD500.00
- **7.** Upon receiving the online application, the Maritime Ships Security Department will review and evaluate the Amendment request and will issue the Amendment Approval letter to the Company's operator.

- **8.** In those cases, that the operating companies prefer that their Ship Security Plans are approved by another Recognized Security Organization authorized, they can do it without previous authorization of this flag.
- **9.** On paragraph 5 of the MMC-131 the Panama Maritime Authority listed several RSO's responsible for the Review and Approval of the Ship Security Plans (SSP) authorized by this Administration.

10. FEES

a. According to the Resolution J.D. No. 026-2020 dated February 27, 2020 the following fee is established:

Evaluation and approval of amendments to the Ship Security Plan for Panamanian flag vessels with a SSP approved by any Recognized Security Organizations, which have been sanctioned by the Panama Maritime Authority, with the total revocation of its authorization to render the services as Recognized Security Organization:

FEES USD500.00

11. All payments can be made at the Panama Maritime Authority offices or at any Panama Merchant Marine Consulate. For bank wires follow the instructions given in the MMC-219, once the wire transfer has been made, please send the receipt along with the vessel's description and service requested to be paid to: with c.c. to: agomez@segumar.com, and according to Merchant Marine Circular MMC-324, in order to issue the PMA official payment receipt that should be attached in the E-Segumar Platform.
